# IMPORTANT INFORMATION ABOUT COMPLETING THE STEPS TO ENROLLMENT

Although the steps are presented in numerical order, keep in mind that you may not necessarily complete all of these steps in the order that they are presented. Refer to MySJSU for specific deadlines and tasks that need to be completed to ensure your enrollment.

# STAY COMMITTED TO THE PROCESS

Deadlines are very important and are in place to help you through the enrollment process. You risk having your admission withdrawn if you do not meet our deadlines and maintain your eligibility. To prevent this from happening, sign in to MySJSU (one.sjsu.edu) every few days and thoroughly read any messages, To-Do List items, or posted deadlines, and take the requested action as soon as possible.

# **Frequently Asked Questions**

### What if I do not complete the required A-G college preparatory courses or miss a deadline?

You will have your admission to SJSU revoked and your registration canceled. In particular, failure to submit your final high school transcripts will result in your application being withdrawn, even if you have signed up for housing, received financial aid, registered for classes, and attended orientation.

### What if I am planning to take courses required for admission during the Summer 2026 term?

You may not use coursework from the Summer 2026 term to complete admission or impaction requirements.

#### If I want to take the fall semester off, can I defer admission to another term?

No, your admission offer is good for the Fall 2026 term only. You must attend at least one course during the Fall 2026 semester to maintain your admission. If you do not enroll in courses during the term of your admission and wish to be admitted for a later term, you must submit a new application for the next available term for which you meet the minimum requirements.

### Can I change my major?

Due to SJSU campus impaction, a change of major cannot be processed prior to the start of the term and is not guaranteed even after admission to SJSU. If you are Undeclared, you will receive more information about declaring your major during orientation.

Note: Military students may be exempt from reapplying due to certain military obligations. For more information, please contact the Veteran Resources Center (sisu.edu/veterans).

# **Submit**Intent to Enroll

We hope that you will join us for Fall 2026! To be able to plan for our new students, we need to know if you intend to enroll. To submit your intent to enroll, go to the Next Steps Intent to Enroll website (nextsteps.sjsu.edu) and complete the multi-step process by 11:59 p.m. (Pacific Daylight Time) no later than the date posted on MySJSU. Note that if you do not meet this deadline, we will assume that you do not want to attend SJSU and your admission will be withdrawn.

The Next Steps Intent to Enroll process includes accepting SJSU's offer of admission, signing up for mandatory orientation, and paying the \$250 nonrefundable enrollment deposit.

YES - I intend to enroll at SJSU for the Fall 2026 semester (Please note: You may not defer your enrollment to a later semester.)

NO – I will not attend SJSU for the Fall 2026 semester (Your application will be withdrawn from further consideration.)

# Sign Up for Sparta Camp (Orientation)

**Sparta Camp is the mandatory two-day, in-person, orientation program** that will introduce you to the campus and its resources, connect you to your college and major department, and provide you with critical academic planning information. All admitted students are required to attend this mandatory orientation for the entire duration of the program. Overnight accommodations are available for students traveling from out of the area. The cost to attend orientation will be included in your \$250 enrollment deposit.

## **During orientation, we will:**

- Discuss and explain key university services
- Facilitate connections with other staff, faculty, and your fellow incoming students
- Host a General Education advising workshop to help in planning your academic schedule

- Provide you with information about campus programs and services
- Assist you in making the transition to college

# Pay Enrollment Deposit

In order to complete the Next Steps Intent to Enroll process and reserve your spot to attend SJSU, you must submit your nonrefundable enrollment deposit by the deadline. You will be prompted to pay your nonrefundable enrollment deposit online via a link provided in your Next Steps portal. The \$250 enrollment deposit includes your orientation payment and a deposit towards your tuition and fees for Fall 2026.

Please note: The \$250 enrollment deposit is nonrefundable, even if you do not enroll in classes for the Fall 2026 semester.

# Submit Final Official Transcripts (with Graduation Date)

# **High School Transcripts**

We will review your final official transcripts to verify that you completed all required courses for admission. This includes passing required courses with a "C-" or better. Final official transcripts must include your graduation date and must be submitted by **Wednesday, July 15**.

# **College Transcripts (if applicable)**

You will also be required to submit official college transcripts for any courses completed at a community college.

# **Official Exam Results**

Although SAT and ACT scores are no longer used in the admission process, they can still help us to determine the best English and math course placement in your first year.

If you have SAT/ACT scores available, please send those to SJSU as soon as possible.

# **Determine**First Year Writing and Math Course Placement

To facilitate appropriate first-year course placement, the CSU evaluates your academic preparation in two areas: written communication and math/quantitative reasoning.

The evaluation takes into account several factors, including overall grade point average, mathematics grade point average, completed terms of secondary coursework, grades in certain senior-year classes, the Reflection on College Writing, and scores on standardized tests such as the SAT, ACT, CAASPP/EAP, CLEP, Advanced Placement, Advanced Level, Advanced Subsidiary, and International Baccalaureate examinations.

Though SJSU will not consider SAT/ACT scores in our evaluation of your record for admission, please submit any available official SAT/ACT scores as they could help determine your first-year course placement.

# **First Year Writing Course Placement**

First-Time, First-Year Students entering SJSU will complete an online Reflection on College Writing exercise to explore writing at SJSU and to choose the course they need. The online exercise is offered through Canvas (SJSU's online course tool) and will be available at the beginning of June. Be alert for emails and MySJSU messages about the Reflection on College Writing. To ensure that you will be able to register for your first-year writing course during Sparta Camp, complete all modules in your Reflection on College Writing at least two weeks prior to your orientation session. Messages and emails will be posted if there are sections that are not fully complete; be sure to monitor MySJSU and your @sjsu.edu email account.

# **First Year Math Course Placement**

Your math placement is dependent upon your major and your enrollment category. You can confirm your major by reviewing your admission letter. To determine your math course placement, please complete the following:

# **Precalculus Proficiency Assessment**

If your major requires calculus, you will be required to take the Precalculus Proficiency Assessment (PPA) unless:

• You have earned a three or better on the AP Precalculus Exam or an AP Calculus Exam.

(Request to have the appropriate testing agency send your official score report to SJSU as soon as it is available.)

You have earned a "C-" or better in a transferable Pre-Calculus level course at a community college.
 (Send us your official transcript reflecting this work as soon as possible.)

If you took the Calculus AP exam in high school and have not yet sent us your scores, please contact the Testing Office at testing-office@sjsu.edu to determine your next steps.

If you feel that your assigned mathematics enrollment category is not accurate, you may submit an appeal. For your appeal to have merit, it must bring to light new or missing information that was not considered in the original determination. Transfer coursework submitted after the transcript deadline or test scores sent after the official test score deadline are the basis for an appeal. To initiate an appeal, send an email to supportedinstruction@sjsu.edu with the subject line, "Math Enrollment Category Appeal." Be sure to include your full name and SJSU ID number.

# **Immunizations and Records**

As a new student, you will need to provide proof of immunizations prior to the first day of classes to avoid delays with housing applications, class registration and/or participation in programs.

### **CSU Required Immunization**

• Hepatitis B Vaccine: Full immunization series completed. All incoming students who are 18 years of age or younger on the first day of their first term must submit proof of Hepatitis B immunization.

## **Additional Requirements for SJSU University Housing and International Students**

- Measles, Mumps, and Rubella (MMR) vaccine
- Meningococcal conjugate (Men ACWY) vaccine
- Tuberculosis (TB) screening form (available in Student Wellness Center Patient Portal)

# **California Residency for Tuition Purposes**

The determination of residency for tuition purposes affects whether a student pays in-state or out-of-state tuition fees. Out-of-state tuition fees are higher than in-state tuition fees. Just because a student is or has been a resident of the State of California does not mean that he or she qualifies to receive the in-state tuition rate. Certain requirements, established under California law, must be met.

You must file an affidavit (sjsu.edu/registrar/docs/AB\_540.pdf) with SJSU. You will need to show proof of attendance and graduation.

# **Installment Payment Plans**

The university offers payment plans to help students and their families make their payments over a period of time. Two payment plans are offered for the fall and spring semesters:

- Tuition and fees payment plan
- Housing payment plan

Students may sign up for both plans if needed and each payment plan has a \$35 fee. The initial payment includes campus mandatory fees, optional Student Involvement and Representation (SIRF) fee, First Day Solutions charges and miscellaneous class fees. These fees must be paid by your payment due date and are not included in the installments.

Eligible charges that can be divided into installment payments include tuition fees, non-California resident fees, and graduate professional business program fees. A student must have a minimum of \$1,000 in eligible charges to qualify for the payment plan.

# Refunds

Students are highly encouraged to enroll in Direct Deposit. With Direct Deposit, you receive your refund several days quicker than a paper check and more securely. To enroll, log in to MySJSU, scroll to Finances and select Enroll in Direct Deposit.

# **Keeping Your MySJSU Account Current**

SJSU has established a business practice whereby all payments apply to the oldest debt on your account. For example, if you are making a registration payment and you have a housing debt with an earlier due date, the payment will apply to the housing charges first. Keep your account current to avoid the possibility of enrollment cancellation. Any delinquent outstanding charges owed to the university will be submitted to the Franchise Tax Board for tax refund offset. The university, or its agent, has the right to pursue collections in order to repay a delinquent debt owed to the university.

### California Dream Act – State aid for undocumented students

AB540 students (undocumented immigrant status) may qualify for state grant programs that make up the California Dream Act. The California Dream Act is the result of two bills, Assembly Bill 130 (AB 130) and Assembly Bill 131 (AB 131). For the California Dream Application, you will need SJSU's six-digit code, which is 001155.

## **Applying for Aid**

Once you apply for financial aid (either via the FAFSA or California Dream Act Application), SJSU's Financial Aid Office will post requests on your MySJSU student account for documents required to determine if you are eligible for financial aid and how much you are eligible to receive.
