IMPORTANT INFORMATION ABOUT COMPLETING THE STEPS TO ENROLLMENT

Although the steps are presented in numerical order, keep in mind that you may not necessarily complete all of these steps in the order that they are presented. Refer to MySJSU for specific deadlines and tasks that need to be completed to ensure your enrollment.

STAY COMMITTED TO THE PROCESS

Deadlines are very important and are in place to help you through the enrollment process. You risk having your admission withdrawn if you do not meet our deadlines and maintain your eligibility. To prevent this from happening, sign in to MySJSU (one.sjsu.edu) every few days and thoroughly read any messages, To Do List items, or posted deadlines and take the requested action as soon as possible.

We are excited to welcome you to San José State University, the founding campus of the California State University (CSU) system. Please know you still have steps to take to stay admitted and officially enroll for Fall 2026. This guide includes detailed information to help you complete each of the required steps.

Frequently Asked Questions

What if I do not complete the required A-G college preparatory courses or miss a deadline?

You will have your admission to SJSU revoked and your registration canceled. In particular, failure to submit your final high school transcripts will result in your application being withdrawn, even if you have signed up for housing, received financial aid, registered for classes, and attended orientation.

What if I am planning to take courses required for admission during the Summer 2026 term?

You may not use coursework from the Summer 2026 term to complete admission or impaction requirements.

If I want to take the fall semester off, can I defer admission to another term?

No, your admission offer is good for the Fall 2026 term only. You must attend at least one course during the Fall 2026 semester to maintain your admission. If you do not enroll in courses during the term of your admission and wish to be admitted for a later term, you must submit a new application for the next available term for which you meet the minimum requirements.

What if I'm a California Community College transfer?

Keep your own copy of the general education plan from your community college. Keep track of the courses you've completed to meet the General Education (GE) requirements. Work with our academic advisors to complete the remaining courses at SJSU.

Note: Military students may be exempt from reapplying due to certain military obligations. For more information, please contact the Veteran Resources Center (sjsu.edu/veterans).

Can I change my major?

Because SJSU is an impacted campus, change of majors cannot take place prior to the start of the term and is never guaranteed even after admission to SJSU.

Submit Intent to Enroll

We hope that you will join us for Fall 2026! To be able to plan for our new students, we need to know if you intend to enroll. To submit your intent to enroll, go to the Next Steps Intent to Enroll website (nextsteps.sjsu.edu) and complete the multi-step process by 11:59 p.m. (Pacific Daylight Time) no later than the date posted on MySJSU. Note that if you do not meet this deadline we will assume that you do not want to attend SJSU and your admission will be withdrawn.

The Next Steps Intent to Enroll process includes accepting SJSU's offer of admission, signing up for mandatory orientation, and paying the \$250 nonrefundable enrollment deposit.

YES – I intend to enroll at SJSU for the Fall 2026 semester **(Please note: You may not defer your enrollment to a later semester.)**

NO – I will not attend SJSU for the Fall 2026 semester (Your application will be withdrawn from further consideration.)

You will need the following to submit your intent to enroll:

- Your nine-digit SJSU ID (provided on your Letter of Admission)
- Your SJSUOne password

Sign Up for Spartan Experience for Transfers (Orientation)

Spartan Experience for Transfers is the mandatory one-day, in-person orientation program that will introduce you to the campus and its resources, connect you to your college and major department, and provide you with critical academic planning information. All admitted students are required to attend this mandatory orientation for the entire duration of the program. The cost to attend orientation will be included in your \$250 enrollment deposit.

Before attending Spartan Experience for Transfers (Orientation), complete Spartan Link (spartanlink.sjsu.edu) online pre-orientation

During orientation, we will:

- Discuss and explain key university services
- Facilitate connections with other staff, faculty and your fellow incoming students
- Host a General Education advising workshop to help in planning your academic schedule

Trained Orientation Leaders will:

- Answer some of your initial questions
- Provide you with information about campus programs and services
- Assist you in making the transition to SJSU

Parents and family members are invited to attend Parent and Family Orientation, held concurrently with your orientation session. Orientation registration for parents and families will become available in Step 3 of your student's Next Steps portal (nextsteps@sjsu.edu) after your student has completed the Intent to Enroll process.

Pay Enrollment Deposit

In order to complete the Next Steps Intent to Enroll process and reserve your spot to attend SJSU, you must submit your nonrefundable enrollment deposit by the deadline. You will be prompted to pay your nonrefundable enrollment deposit online via a link provided in your Next Steps portal. The \$250 Enrollment Deposit includes your orientation payment and a deposit towards your tuition and fees for Fall 2026.

Please note: The \$250 enrollment deposit is nonrefundable, even if you do not enroll in classes for the Fall 2026 semester.

GI Bill recipients: Please submit GI Bill documentation via MySJSU under the Veterans Benefit section to determine eligibility for an enrollment deposit waiver.

Partial and Final Official Transcripts

We will review your partial and final official transcript(s) to verify that you completed all required courses for admission.

This includes passing required courses with a “C-” or better. Partial official transcripts show all completed coursework from all institutions that you have attended as well as in-progress coursework and must be submitted by Monday, March 23. Final official transcripts must include all completed coursework from all institutions that you have attended and must be submitted by Wednesday, July 15. If you have AP, IB or CLEP exam results, please have official score reports sent to SJSU by the testing agency.

Submit Immunization Records

Immunizations and Records

As a new student, you will need to provide proof of immunizations prior to the first day of classes to avoid delays with housing applications, class registration and/or participation in programs.

CSU Required Immunization

- Hepatitis B Vaccine: Full immunization series completed. All incoming students who are 18 years of age or younger on the first day of their first term must submit proof of Hepatitis B immunization.

Additional Requirements for SJSU University Housing and International Students

- Measles, Mumps, and Rubella (MMR) vaccine
- Meningococcal conjugate (Men ACWY) vaccine
- Tuberculosis (TB) screening form (available in Student Wellness Center Patient Portal)

Complete Upper-Division Writing Directed Self Placement Exercise

The Upper-Division Writing Directed Self-Placement (UDW-DSP) is an exercise (not a test) that helps students place themselves in the appropriate writing course at SJSU. Before registering for an upper division writing course (100W), students must earn a "C-" or better grade in a GE Area 1B: Critical Thinking (formerly GE Area A3) or equivalent second-semester composition course and complete the UDW-DSP.

What you need to do:

- Make sure you have met the above criteria in order to complete the UDW-DSP
- Go to sjsu.edu/wac/wst and read the information provided
- Click on the link "Begin the Upper-Division Writing Directed Self-Placement Exercise" and complete the exercise (this will only take 10-15 minutes)
- Make sure you complete the UDW-DSP before you enroll in your courses at SJSU

Department Exams (If Required)

Register for Classes

Your registration appointment will be posted to MySJSU. We encourage you to use MyScheduler (in MySJSU Student Center) to plan your course schedule. This tool allows you to pre-program in breaks or time conflicts before calculating several possible course schedules to choose from. Once you have chosen the optimal schedule, those courses can be sent to your MySJSU account to complete your course registration.

Registration Appointments

You will register for classes during orientation if you have submitted all official transcripts, documents, and test scores. Be sure to send these official transcripts, documents, and test scores by the deadline posted in MySJSU. These are required to verify your eligibility to enroll and minimize delays in the assignment of your registration appointment.

Attend Spartan Experience for Transfer (Mandatory Orientation)

To maintain your eligibility to enroll, you must attend your scheduled Spartan Experience for Transfers orientation.

Registering for Courses

Sign in to one.sjsu.edu and search for "MyScheduler." MyScheduler will allow you to pre-plan your course schedule and send that schedule to MySJSU to complete enrollment once you are eligible.

Registration Holds

Check to see if you have a hold that will prevent you from registering by logging in to MySJSU. Visit sjsu.edu/registrar/registration/registration-holds.php and follow the steps to view any holds and learn how to resolve them.

Registration after the First Day of Class

You can still register on the first day of instruction and before the add deadline if space is available. Keep in mind that some classes may already be full, so getting the ones you want could be challenging.

What will I need to register for classes?

- A file of your SJSU admission information, including admission letters, grade reports, copies of transcripts from other schools, copies of AP and placement test scores, and everything related to your enrollment.
- Attend all segments of the mandatory orientation.
- The SJSU Catalog for descriptions of classes, major and minor requirements, available at catalog.sjsu.edu

Once I've registered, can I change my schedule?

If work or family obligations require you to change your schedule, you may make changes to your class schedule before the last day to drop/add classes.

Important note: Before dropping/swapping any class(es) from your schedule to enroll in a different class, be sure you can successfully add the other course(s). Classes at SJSU fill up quickly. If a course you want is full, search for open sections via MySJSU or place yourself on the class waitlist. It is not guaranteed that you will be able to enroll into waitlisted courses.

Can I still get academic advising if my transcripts have not been fully evaluated?

Yes. Advisors will advise you on general university expectations and graduation requirements, including general education course requirements. However, once you get your transcript fully evaluated by Admissions, you must meet with an Academic Advisor for your program again to re-examine your general education checklist and progress toward degree completion because changes to your academic plan may have to be made. This is essential if you plan to graduate in a timely manner.

What if I don't register for the Fall 2026 semester?

Your admission is only good for the Fall 2026 semester. You must attend at least one course during the Fall 2026 semester to maintain your admission. If you do not enroll in courses during the term of your admission and wish to be admitted for a later term, you must submit a new application for the next available term for which you meet the minimum requirements.

California Residency for Tuition Purposes

The determination of residency for tuition purposes affects whether a student pays in-state or out-of-state tuition fees. Out-of-state tuition fees are higher than in-state tuition fees. Just because a student is or has been a resident of the State of California does not mean that he or she qualifies to receive the in-state tuition rate. Certain requirements, established under California law, must be met.

In-state Tuition for Certain Non-residents of California (AB 540 provisions)

If you attended high school in California for at least three full years and graduated or earned an equivalent degree, you may be eligible for resident (in-state) tuition. You must file an affidavit (sjsu.edu/registrar/docs/AB_540.pdf) with SJSU. You will need to show proof of attendance and graduation.

Installment Payment Plans

The university offers payment plans to help students and their families make their payments over a period of time. Two payment plans are offered for the fall and spring semesters:

- Tuition and fees payment plan
- Housing payment plan

Students may sign up for both plans if needed and each payment plan has a \$35 fee. The initial payment includes campus mandatory fees, optional Student Involvement and Representation (SIRF) fee, First Day Solutions charges and miscellaneous class fees. These fees must be paid by your payment due date and are not included in the installments.

Eligible charges that can be divided into installment payments include tuition fees, non-California resident fees, and graduate professional business program fees. A student must have a minimum of \$1,000 in eligible charges to qualify for the payment plan.

Field Trip Fees

A few courses have additional field trip fees ranging from \$11 to \$52.

Special or Optional Fees

Parking permits are available for students. A daily one-semester parking permit is estimated at \$192.

Refunds

Students are highly encouraged to enroll in Direct Deposit. With Direct Deposit, you receive your refund several days quicker than a paper check and more securely. To enroll, log in to MySJSU, scroll to Finances and select Enroll in Direct Deposit.

Bookstore Charges

Registered students can charge books and supplies purchased at the Spartan Bookstore to their MySJSU student account up to \$900 per semester. For more details visit sjsu.edu/bursar/our-services/spartan-bookstore-voucher.php

Keeping Your MySJSU Account Current

SJSU has established a business practice whereby all payments apply to the oldest debt on your account. For example, if you are making a registration payment and you have a housing debt with an earlier due date, the payment will apply to the housing charges first. Keep your account current to avoid the possibility of enrollment cancellation. Any delinquent outstanding charges owed to the university will be submitted to the Franchise Tax Board for tax refund offset. The university, or its agent, has the right to pursue collections in order to repay a delinquent debt owed to the university.

To help cover the cost of attending SJSU, you can apply for financial aid, which is provided in the form of federal grants, state grants, work study, and loans, by using the Free Application for Federal Student Aid (FAFSA) at studentaid.gov

California Dream Act – State aid for undocumented students

AB540 students (undocumented immigrant status) may qualify for state grant programs that make up the California Dream Act. The California Dream Act is the result of two bills, Assembly Bill 130 (AB 130) and Assembly Bill 131 (AB 131). For the California Dream Application, you will need SJSU's six-digit code, which is 001155.

Applying for Aid

Once you apply for financial aid (either via the FAFSA or California Dream Act Application), SJSU's Financial Aid Office will post requests on your MySJSU student account for documents required to determine if you are eligible for financial aid and how much you are eligible to receive.
