

## SJSU Online Transfer Provisional Admission Agreement | Summer 2026

This offer of admission to the academic plan (major) listed on your admission letter is only valid for this term and may not be deferred to another semester. You must enroll in at least one course during the Summer 2026 semester to maintain your admission. To ensure your enrollment and attendance at SJSU Online, all of the mandatory steps below must be completed.

**Returning SJSU Students:** All returning SJSU students must comply with all deadlines and admission requirements included in this document.

### Mandatory Steps to Enrollment

You must meet all deadlines and conditions of your admission as indicated below and in MySJSU.

☐ **Send final transcripts by Friday, May 1, 2026**

If you have work in progress, send your official, final transcript(s), including grades for the Fall 2025 term, no later than May 1, 2026. Failure to submit your transcript(s) will result in your admission being withdrawn.

☐ **Send official test scores needed to fulfill admission requirements**

If you have taken and passed AP, IB, or CLEP exams to satisfy any of the CSU admission requirements, request that your official scores be sent to SJSU.

☐ **Monitor MySJSU to avoid the cancellation of your admission**

Failure to meet deadlines will result in your admission being withdrawn. You can avoid your admission being withdrawn by carefully and frequently monitoring MySJSU ([one.sjsu.edu](https://one.sjsu.edu)) throughout the entire admission process.

☐ **Meet Immunization/Vaccination Requirements**

☐ **Register for courses**

Registration for new transfers will begin May 4, 2026. To be eligible, we must have received and reviewed your official transcript(s).

### Provisional Admission

If you have work in progress, this offer of admission is considered provisional and based on the academic information reported on your Cal State Apply application and related application materials. All of your academic information must be verified before you will be allowed to enroll and register for classes at SJSU. Your admission will remain “provisional” until your official, final transcript(s) passes verification.

☐ **Meet the CSU minimum requirements for upper division transfer admission**

Your official, final transcript(s) must show that you meet the CSU transfer admission requirements in order to pass final verification. To ensure that your provisional admission passes final verification, make sure your official, final transcript(s) meets the following criteria:

- You must have an overall GPA of 2.0 or higher.
- You must be in good standing at the last college or university attended.
- You must meet the four basic skills course requirements with a grade of “C-” or higher by the end of the Fall 2025 term. A grade of “D+” or lower will not meet this requirement. SJSU will accept “Credit” or “Pass” for transferable college courses completed in Winter, Spring, Summer or Fall 2020 terms and in Winter, Spring or Summer 2021 terms to satisfy the four basic skills course requirements.
- You must complete at least 60 transferable semester (90 quarter) units by the end of the Fall 2025 term.
- If required, complete supplemental coursework with a “C” or better grade. Visit the SJSU Online website at [sjsu.edu/online](https://sjsu.edu/online) for program-specific requirements.

**Be advised:** If you have any outstanding documents, such as official transcripts, that are past due at the time of registration, your eligibility to register could be delayed until they are received and processed (which can take up to two weeks).
